Born and Raised – Native Nevadans

PURPOSE:

This Fact Sheet highlights population shifts and investigates the adult population of Nevada counties. Data from a 2017 GOVERNING¹ report details Nevada's counties and their populations.

GOVERNING DEFINES POPULATIONS:

Data from adults 25 years or older are included to examine the population makeup of each county in Nevada. Adults residing in each county are divided into either a native-born resident or *transplants* if they relocated from another state, or country. The original source separates *transplants* into three separate categories;

1. Adults born in other states
2. U.S. natives born outside the country (e.g. an individual who was born abroad at a U.S. military base)
3. Foreign born adults

A NATIONAL PERSPECTIVE OF POPULATIONS:

The United States is home to a diverse population of people from a variety of countries. When looking at the United States as a whole, most states retain close to half of their native born populations. Certain states have more homegrown populations than others. One of the most prominent examples of this is found in the Cajun county of Louisiana. In this area, only 1 out of 10 adults are not native to Louisiana. In contrast, the opposite dynamic is found in certain counties in Nevada; 9 out of every 10 adults in Clark, Douglas, Nye, and Storey counties are not native to the Silver State.

WHAT IS THE CAUSE OF POPULATION SHIFTS?

On a national level, economic activity is one of the largest factors contributing to population shifts within counties. The appeal of new opportunities through jobs, innovation, and education help to attract people to a given state. In counties that lack these opportunities, people are more likely to migrate away.

KEY TAKEAWAYS:

1. In every county in Nevada, there are more adult residents born outside the state than adults born in Nevada.
2. Rural counties are less likely to have a high number of foreign born adults.
3. Just 7.8% of adults in Clark County were born in Nevada. This represents the lowest share of adults born in Nevada across the state's 16 counties.
