## HOSPITAL BED CAPACITY IN NEVADA COUNTIES

Health Fact Sheet No. 5 | April 2020

### PURPOSE:

This Fact Sheet shows data on hospital bed capacity within Nevada's 17 counties, as originally published by *High Country News* on March 19, 2020.<sup>1</sup> The original data source includes maps and charts compiled by Megan Lawson of Headwater Economics. The data include information from the Department of Homeland Security and the Department of Commerce.

### KEY TAKEAWAYS:

1. On an average, "rural areas in the West actually have more hospital beds per person than urban areas."<sup>2</sup>
2. In Nevada, Esmeralda County, Eureka County, and Storey County list no hospital beds within their boundaries; Lander County reports just 7 hospital beds and White Pine County reports 12 hospital beds.
3. In Washoe County (Reno) there are .003 hospital beds per person; in Clark County (Las Vegas) there are .002 beds per person.
4. In Storey County, 29.8% of the population is over 65 years of age, the highest percentage in Nevada. 26.4% of residents in Douglas County are over 65 years of age.
5. Of the 11 western states included in this report, Nevada ranks 10<sup>th</sup> with 6,752 residents in counties without a hospital; 1,728 of those individuals are 65+ years old

### ABOUT THE DATA:

Table 1 displays current hospital bed capacity in Nevada counties, adapted from the original report by Headwater Economics. Urban counties (Clark and Washoe) are shown separately from rural counties. Within each county category, counties are organized alphabetically within the table. Data are presented for the total resident population per county, in addition to the number of individuals aged 65 and older (seniors) in the total resident population. The percent of seniors within a county population is also offered. Then, data are presented on the number of hospital beds available in each county, and the number of beds therefore available per resident. Finally, the table shows the number of hospital beds available per resident aged 65 and older.

Among Nevada's urban counties, there are more hospital beds per resident in Washoe County (0.003) than in Clark County (0.002). Despite this, Clark and Washoe counties have proportionally similar-sized populations of residents 65 and older (Clark, 14.10%; Washoe, 15.50%).

In Nevada’s rural counties, Esmeralda County, Storey County and Eureka County do not have any hospital beds within their boundaries. Esmeralda and Storey Counties have two of the highest shares of senior populations, who are often most vulnerable to disease and ailing health. Segerstrom notes that a lack of accessible healthcare facilities “can be especially challenging for people over 65 who often face additional challenges reaching the nearest hospital even as they face higher risk of extended hospitalization and death from COVID-19.”<sup>3</sup> Eureka County has a lower share of senior residents, but it is still important to note that there are no hospital beds within county limits. Residents in these counties must seek medical care elsewhere.

Nye County has the second highest county percentage of seniors within its population (28.9%) and has 0.002 hospital beds per resident 65 and older, and only 0.001 hospital beds per resident overall. In rural counties, residents may be more susceptible to disease without access to appropriate medical care within their own county of residence.

Pershing County has the greatest hospital bed capacity of all Nevada counties, with 0.006 hospital beds per resident, and 0.036 hospital beds per resident 65 and older. Lincoln County and Carson City rank second, each with 0.004 hospital beds per resident.
