


#### **THE CONGRESSIONAL CAUCUS 1800 - 1828**

#### PARTY BOSSES AND ELECTED OFFICIALS – 1831 TO 1968





#### **SIX KEY RULES THAT TRANSFORMED THE NOMINATING PROCESS**

- FIRST TIER CAUCUSES MUST BE OPEN TO ANYONE WISHING TO BE KNOWN AS A DEMOCRAT
- FIRST TIER CAUCUSES MUST BE HELD SIMULTANEOUSLY THROUGHOUT THE STATE
- EVERY PARTICIPANT AT EVERY LEVEL, INCLUDING CANDIDATES FOR DELEGATE MUST DECLARE THEIR PRESIDENTIAL PREFERENCE
- BAN ON USE OF THE UNIT RULE
- DELEGATES MUST "FAIRLY REFLECT" THE WILL OF THE VOTERS
- STATES MUST USE AFFIRMATIVE ACTION IN THE DELEGATE SELECTION PROCESS
- THESE CHANGES REFORMED THE REPUBLICAN PARTY AS WELL

## CONSEQUENCES

- THE NUMBER OF PRIMARIES INCREASES
- ALMOST ALL PRIMARIES BECOME "BINDING"
- UNCOMMITTED DELEGATES DISAPPEAR FOR THE MOST PART
- THE EARLY STATES INCREASE IN IMPORTANCE BECAUSE OF THE "MOMENTUM" FACTOR
- THE SELECTION OF DELEGATES MOVES EARLIER IN THE CONVENTION YEAR -"FRONTLOADING"

#### THE NUMBER OF PRESIDENTIAL PRIMARIES EXPLODES

# PRE-REFORM AVERAGE PER YEAR 1932 – 1968 = 15 POST-REFORM AVERAGE PER YEAR 1972 – 2020 = 30

#### IS THERE ANOTHER WAY? IS IT BETTER?

- A NATIONAL PRIMARY FOR EACH PARTY
- REGIONAL PRIMARIES/ROTATING REGIONAL PRIMARIES
- PRIMARY DAYS ON WHICH THERE ARE A VARIETY OF TYPES OF STATES: BIG STATES, SMALL STATES, RURAL URBAN, REGIONAL ETC.
- ROTATING EARLY PRIMARY STATES
- ALLOW FOR PARTY LEADERS AND ELECTED OFFICIALS TO HAVE A GREATER SAY IN THE CHOICE OF A NOMINEE
