This expansion, which required fertile land near ports or--later in this period--railroads, first took place at the narrow western Havana. The next major thrust was into the province neighboring Havana to the east, Matanzas, whose gently rolling hills with deep clay soils yielded half the cane grown in Cuba in the 1850s.
